PUBLIC COMMISSION MEETING

WEDNESDAY, OCTOBER 24, 2018

The monthly Public Meeting of the Commission was called to order by Chairman Charles P. Shotmeyer on Wednesday, October 24, 2018 at 9:07 a.m., One F.A. Orechio Drive, Wanaque, New Jersey.

Chairman Charles P. Shotmeyer, Vice Chairman Howard L. Burrell and Commissioners Alan S. Ashkinaze, Jerome P. Amedeo, and Donald C. Kuser were recorded present. Also present were Timothy J. Eustace, Executive Director, Todd R. Caliguire, Deputy Executive Director, John Wyciskala, Esq., Commission Counsel from the law firm of Inglesino, Webster, Wyciskala & Taylor, LLC and Edmund Caulfield, Senior Counsel of the Governor's Authority Unit. Commissioner Robert C. Garofalo was absent.

Chairman Shotmeyer asked everyone to stand and recite the Pledge of Allegiance.

WHEREAS, the Commission has determined that it is necessary to reallocate funds from the 2015 South Bonds in order to address the immediate funding concerns; and

WHEREAS, the Commission's staff has prepared a 2015 South Bonds Reallocation List which would transfer the balances from capital projects with excess funds to capital projects that are currently underfunded, and the Commission desires to approve said Reallocation List.

WHEREAS, the North Jersey District Water Supply Commission ("Commission") is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its participating municipalities; and

WHEREAS, the Commission's Chief Financial Officer has determined that there are not sufficient funds available in the General Capital Account to pay for certain projects (Painting of Filter Bay Roof and Piping, and Asset Management Study), and funds need to be transferred from the Capital Reserve Accounts to pay for the projects.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission that the transfer of \$725,000.00 from the Commission's Capital Reserve Accounts (\$479,950.00 from the Wanaque North account and \$245,050.00 from the Wanaque South account) to the General Capital Account is hereby authorized; and

BE IT FURTHER RESOLVED that a copy of this resolution shall be maintained in the office of the Executive Director and made available for public inspection.

Commission Secretary Kim Diamond read the following resolution:

RESOLUTION OF THE NORTH JERSEY DISTRICT WATER SUPPLY COMMISSION AUTHORIZING THE AWARD AND EXECUTION OF CONTRACT #2031-SODIUM HYPOCHLORITE TANKS ENCLOSURE

WHEREAS, the North Jersey District Water Supply Commission ("Commission") is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its participating municipalities; and

WHEREAS, the Commission stores its sodium hypochlorite disinfectant in four (4) tanks; and

WHEREAS, the Commission's operations staff recommended that the Commission put out a public bid for the construction of a steel enclosure to house the Commission's sodium hypochlorite tanks; and

WHEREAS, the Commission published a request for bids for the excavation of four (4) new concrete footings, formwork, placement of steel reinforcement and concrete to support a new steel enclosure to house the existing sodium hypochlorite tanks (Contract #2031), and the bid documentation also requested that each bidder provide an additional price for the erection of a steel enclosure building (the "Construction Services"); and

WHEREAS, a bid opening for Contract #2031 was held by the Commission on October 4, 2018, at which time bids were received from three firms; and

WHEREAS, the Commission's evaluation committee reviewed and evaluated the bids and determined that Paving Materials & Contracting, LLC ("Paving Materials") submitted the lowest and most responsible bids for both aspects of the Construction Services, and recommended that Paving Materials be awarded the contract in accordance with the Commission's enabling legislation and applicable State law; and

WHEREAS, Paving Materials submitted a bid in the amount of \$34,608.00 for the concrete footings, formwork, placement of steel reinforcement and concrete to support the steel enclosure, and \$74,500.00 for the erection of a steel enclosure building, for a total not-to-exceed contract amount of \$109,108.00, and the Commission has determined that the pricing proposed by Paving Materials is reasonable; and

WHEREAS, the Commission has further determined that Paving Materials possesses the requisite expertise and capability to perform the services; and

WHEREAS, the Commission desires to retain the services of Paving Materials in accordance with the bid documents, Contract #2031, and its bid; and

WHEREAS, the award of this contract is necessary for the Commission's efficient water treatment operations, the protection of the Commission's water supply facilities, and the health, safety and welfare of the public; and

WHEREAS, the Chief Financial Officer of the Commission has certified that the funds will be available for Contract #2031.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission that a contract for the Construction Services be awarded to Paving Materials as the lowest and most responsible bidder, in accordance with the Commission's enabling legislation and applicable State law, for the not-to-exceed amount of \$109,108.00; and

BE IT FURTHER RESOLVED that the Executive Director and General Counsel are hereby authorized to prepare a contract for the Construction Services, incorporating the Commission's requirements as set forth in the bid documents, Contract #2031, and Paving Material's bid; and

BE IT FURTHER RESOLVED that the Chairman or Vice Chairman of the Commission is hereby authorized to execute such a contract and the Secretary of the Commission is authorized to attest to the signature of either the Chairman or Vice Chairman; and

BE IT FURTHER RESOLVED that a copy of this resolution and the contract shall be maintained in the Office of the Executive Director and made available for public inspection.

Commission Secretary Kim Diamond read the following resolution:

RESOLUTION OF THE NORTH JERSEY DISTRICT WATER SUPPLY COMMISSION AUTHORIZING THE AWARD AND EXECUTION OF A CONTRACT FOR CONSULTING ENGINEERING SERVICES FOR WORK ASSOCIATED WITH AN ASSET MANAGEMENT STUDY

WHEREAS, the North Jersey District Water Supply Commission ("Commission") is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its participating municipalities; and

WHEREAS, on July 21, 2017, the New Jersey legislature adopted the Water Quality Accountability Act (the "WQAA"), N.J.S.A. 58:31-1 et seq., establishing new requirements for purveyors of public water systems to improve the safety, reliability and administrative oversight of water infrastructure; and

WHEREAS, among other things, the WQAA requires certain water purveyors to create and implement an asset management plan to inspect, maintain, repair and renew its infrastructure consistent with standards established by the American Water Works Association; and

WHEREAS, the provisions of the WQAA do not apply to the Commission, nevertheless the Commission believes that it is in its best interest to voluntarily follow certain of the guidelines and technical requirements of the WQAA in order to improve the safety, reliability and oversight of the Commission's infrastructure; and

WHEREAS, the Commission is empowered by law to appoint and employ professionals, technical advisors and experts as the Commission may determine to be necessary for its efficient operation; and

WHEREAS, the Commission has been empowered pursuant to its enabling legislation – specifically <u>N.J.S.A.</u> 58:5-20 – to solicit proposals in writing and award contracts after public advertisement; and

WHEREAS, on or about July 12, 2018, the Commission publicly advertised a request for proposals for the provision of consulting engineering services associated with an asset management study ("Engineering Services") in accordance with the general requirements of the WQAA (RFP #002-2018), and subsequently received several proposals from interested engineering firms on or before September 5, 2018; and

WHEREAS, on September 28, 2018 and October 9, 2018, the Commission's evaluation committee reviewed and evaluated the proposals and determined that Jacobs Engineering Group, Inc. ("Jacobs") submitted the most qualified, responsible, and responsive proposal for the Engineering Services, and has recommended that Jacobs be awarded a contract in accordance with the Commission's enabling legislation and applicable State law as the most qualified, responsible, and responsible, and responsible proposer; and

WHEREAS, Jacobs proposed a not-to-exceed contract price of \$715,000.00 for the performance of the Engineering Services, and the Commission has determined that the price is reasonable based on the necessary scope of work; and

WHEREAS, the Commission has determined that Jacobs possesses the requisite expertise and skilled personnel to perform the Engineering Services; and

WHEREAS, the Commission has determined, on the basis of the foregoing, that Jacobs constitutes the most qualified, responsive, and responsible proposer for the performance of the Engineering Services in accordance with the Commission's enabling legislation and applicable State law; and

WHEREAS, the Commission desires to retain the services of Jacobs to perform the Engineering Services in accordance with the general requirements of the WQAA, the Commission's requirements as set forth in RFP #002-2018, and the proposal submitted by Jacobs; and

WHEREAS, the award of this contract is necessary for the Commission's efficient water treatment operations, the protection of the Commission's water supply facilities, and the health, safety and welfare of the public; and

WHEREAS, the Chief Financial Officer of the Commission has certified that the funds will be available for this contract.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission that a contract be awarded in response to RFP #002-2018 to Jacobs as the most qualified, responsive, and responsible proposer in accordance with the Commission's enabling legislation and applicable State law, for an amount not to exceed \$715,000.00, for the performance of the Engineering Services; and

BE IT FURTHER RESOLVED that the Executive Director and General Counsel are hereby authorized to prepare a contract for the performance of the Engineering Services, incorporating the general requirements of the WQAA, the Commission's requirements as set forth RFP #002-2018, and the proposal submitted by Jacobs; and

BE IT FURTHER RESOLVED that the Chairman or Vice Chairman of the Commission is hereby authorized to execute such a contract and the Secretary of the Commission is authorized to attest to the signature of either the Chairman or Vice Chairman; and

WHEREAS, the North Jersey District Water Supply Commission ("Commission") is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its participating municipalities; and

WHEREAS, the Commission has determined there is a need to retain the services of a licensed contractor to perform services for work associated with vegetation management (the "Contractor Services"); and

WHEREAS, the Commission is empowered by law to appoint and employ professionals, technical advisors and experts as the Commission may determine to be necessary for its efficient operation; and

WHEREAS, the Commission has been empowered pursuant to its enabling legislation – specifically <u>N.J.S.A.</u> 58:5-20 – to solicit proposals in writing and award contracts after public advertisement; and

WHEREAS, on or about March 28, 2017, the Commission publicly advertised a request for proposals for the provision of Contractor Services ("RFP #002-2017"); and

WHEREAS, on or about April 12, 2017, the Commission received one (1) proposal for the provision of Contractor Services from Tuff Greens, LLC ("Tuff Greens") for a lump sum amount of \$71,770.00 per year; and

WHEREAS, on April 26, 2017, the Commission awarded Contract #2014 to Tuff Greens for the provision of the Contractor Services for an initial term of one (1) year, with the Commission maintaining the right to extend Contract #2014, in its sole discretion, for up to two (2) consecutive one (1) year terms; and

WHEREAS, the Commission desires to exercise its right to extend the term of Contract #2014 for an additional one year period as provided in the contract, including without limitation the annual contract price of \$71,770.00 for the provision of Contractor Services; and

WHEREAS, the extension of this contract is necessary for Commission's efficient water treatment operations, the protection of the Commission's water supply facilities, and the health, safety and welfare of the public; and

WHEREAS, the Chief Financial Officer of the Commission has certified that the funds will be available for this contract.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission that Contract #2014 with Tuff Greens be extended for an additional one-year period for an amount not to exceed \$71,770.00 for the provision of the Contractor Services; and

BE IT FURTHER RESOLVED that the Executive Director and General Counsel are hereby authorized to prepare an amendment extending Contract #2014 for an additional year; and

BE IT FURTHER RESOLVED that the Chairman or Vice Chairman of the Commission is hereby authorized to execute such an amendment and the Secretary of the Commission is authorized to attest to the signature of either the Chairman or Vice Chairman; and

BE IT FURTHER RESOLVED that a copy of this resolution and the contract shall be maintained in the Office of the Executive Director and made available for public inspection.

WHEREAS, pursuant to <u>N.J.S.A.</u> 58:5-1 <u>et seq.</u>, the North Jersey District Water Supply Commission ("Commission") is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its participating municipalities, and

WHEREAS, the Commission previously determined there was a need to retain the services of an insurance broker to assist the Commission with its risk management insurance needs for a two-year term (the "Insurance Brokerage Services"); and

WHEREAS, on or about August 15, 2019, the Commission publicly advertised and issued a request for qualifications and proposals ("RFP #006-2018) for the provision of Insurance Brokerage Services and received proposals from interested parties on or before September 7, 2018; and

WHEREAS, the Commission's evaluation committee reviewed and evaluated the four (4) proposals that were submitted and determined that USI Insurance Services ("USI") submitted the most qualified, responsible, and responsive proposal for the Insurance Brokerage Services, and has recommended that USI be awarded a contract in accordance with the Commission's enabling legislation and applicable State law as the most qualified, responsible, and responsible, and responsible, and responsible, and responsible, and responsible proposer; and

WHEREAS, USI proposed a not-to-exceed contract price of \$40,000.00 per year for the performance of the Insurance Brokerage Services, and the Commission has determined that the price is reasonable based on the necessary scope of work; and

WHEREAS, the term of the contract shall be for two years, with the right of the Commission, in its sole discretion, to extend the contract for up to two (2) consecutive one-year terms pursuant to the same contractual price and terms; and

WHEREAS, the Commission has determined that USI possesses the requisite expertise and skilled personnel to perform the Insurance Brokerage Services; and

WHEREAS, the Commission has determined, on the basis of the foregoing, that USI constitutes the most qualified, responsive, and responsible proposer for the performance of the Insurance Brokerage Services in accordance with the Commission's enabling legislation and applicable State law; and

WHEREAS, the Commission desires to retain the services of USI to perform the Insurance Brokerage Services, in accordance with the requirements as set forth in RFP #006-2018 and the proposal submitted by USI for a two-year term; and

WHEREAS, the award of this contract is necessary for the Commission's efficient water treatment operations, the protection of the Commission's water supply facilities, and the health, safety and welfare of the public; and

WHEREAS, the Chief Financial Officer of the Commission has certified that the funds will be available for this contract.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission that a contract be awarded to USI, in accordance with the Commission's enabling legislation and applicable State law, for a two (2) year term in an amount not to exceed \$40,000.00 per year for the performance of the Insurance Brokerage Services, with a right to further extend the contract for up to two (2) consecutive one-year periods subject to the same contract terms; and

BE IT FURTHER RESOLVED that the Executive Director and General Counsel are hereby authorized to prepare a contract for the performance of the Insurance Brokerage Services, incorporating the Commission's requirements as set forth RFP #006-2018, and the proposal submitted by USI; and

BE IT FURTHER RESOLVED that the Chairman or Vice Chairman of the Commission is hereby authorized to execute such a contract and the Secretary of the Commission is authorized to attest to the signature of either the Chairman or Vice Chairman; and

BE IT FURTHER RESOLVED that a copy of this resolution and the contract shall be maintained in the Office of the Executive Director and made available for public inspection.

Commissioner Ashkinaze offered a motion to adopt the resolution authorizing the award and execution of a contract for provision of insurance broker services: risk management; seconded by Vice Chairman Burrell and unanimously approved with Chairman Shotmeyer, Vice Chairman Burrell and Commissioners Ashkinaze, Amedeo and Kuser voting in the affirmative.

Resolution – Authorizing the Emergency Replacement of Sodium Hypochlorite Tanks

Commission Secretary Kim Diamond read the following resolution:

RESOLUTION OF THE NORTH JERSEY DISTRICT WATER SUPPLY COMMISSION AUTHORIZING THE EMERGENCY REPLACEMENT OF SODIUM HYPOCHLORITE TANKS

WHEREAS, the North Jersey District Water Supply Commission ("Commission") is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its participating municipalities; and

WHEREAS, the Commission stores its sodium hypochlorite disinfectant in four (4) tanks and, due to the hazardous properties of this water treatment chemical, tests the integrity of the tanks every five (5) years in accordance with New Jersey Department of Environmental Protection ("NJDEP") standards; and

WHEREAS, as a result of the integrity testing initially performed on two (2) of the sodium hypochlorite tanks, it was discovered that the protective resin on the inside of both tanks has significantly degraded and requires immediate repair; and

WHEREAS, Commission staff anticipate that similar problems may exist on the remaining two (2) sodium hypochlorite tanks; and

WHEREAS, the Commission's operations staff had recommended that the Commission immediately proceed with the repair of the degraded sodium hypochlorite tanks and that such repair work be immediately undertaken as an emergency procurement given the necessity of continuously applying sodium hypochlorite during the water treatment process and the compromised condition of at least (2) and possibly all four (4); and

WHEREAS, by way of Resolution #1792, the Commission authorized the retention of Ryan Herco Flow Solutions ("Ryan") to undertake the necessary repairs to all four (4) tanks, at an initial cost of \$20,000.00 per tank, subject to price increases on a time and material basis depending upon further inspection and investigation once the tank work commences and the levels of degradation ultimately discovered; and

WHEREAS, upon further inspection, Ryan concluded, in consultation with the Commission's engineering department, that the degradation inside the two (2) tanks was significantly greater than originally anticipated, resulting in an expected cost of approximately \$63,200.00, plus potential additional cost overruns; and

WHEREAS, based on the age and make-up of the existing tanks, Ryan further concluded that these repairs may yield only an additional two to three years of operation before these tanks begin to degrade again; and

WHEREAS, as a result of the foregoing, Commission staff requested a proposal from Ryan for the replacement of the tanks in lieu of making repairs that may yield a limited return; and

WHEREAS, Ryan provided a price quote of approximately \$84,000.00 for the provision of two (2), new high-density polyethylene hypochlorite tanks ("HDPE Tanks"), including shipping, and the cost of rigging and crane charges relating to the installation of the two (2) tanks should be approximately \$10,000.00 for a total of \$94,000.00; and

WHEREAS, the HDPE Tanks have a normal life expectancy of ten (10) years, and come with a manufacturer's five (5) year warranty; and

WHEREAS, after review of the information available, and considering the cost of replacement of two (2) tanks at approximately \$63,000.00 with limitations on life expectancy versus an approximate cost of \$94,000.00 for the installation of two (2) new HDPE Tanks with a significantly greater life expectancy, Commission staff has recommended that the Commission proceed with the purchase and installation of the two (2) new HDPE Tanks, and possibly two (2) additional HDPE Tanks, if necessary, after the remaining two (2) sodium hypochlorite tanks are also inspected; and

WHEREAS, pursuant to its enabling legislation, <u>N.J.S.A.</u>, 58:5-20, the Commission is entitled to undertake work by its own employees or outside contractors when the safety or protection of its or other public property or the public convenience requires, or the exigency of the situation will not allow for advertisement or public bidding to address any emergency conditions; and

WHEREAS, pursuant to Section I, Subsection I of its Purchasing Policies and Procedures Manual, the Commission may make purchases of materials and services without the necessity of public bidding when it is determined by the Commission's Executive Director and Chief Financial Officer ("CFO") that an emergency exists; and

WHEREAS, based upon the recommendation of the Commission's operations staff, the Commission's Executive Director and CFO have determined that the internal damage to the sodium hypochlorite tanks constitutes an emergency warranting the immediate replacement of at least two (2) and possibly all four (4) sodium hypochlorite tanks without the necessity of engaging in public advertisement and bidding; and

WHEREAS, Commission staff have recommended that the Commission allocate \$188,000.00 for the emergency replacement of at least two (2) and possibly all (4) sodium hypochlorite tanks, including the cost of rigging and crane charges; and

WHEREAS, the Commission has reviewed Ryan's proposal and the recommendation of its staff and determined that a \$188,000.00 allocation for the emergency work is reasonable under the circumstances; and

WHEREAS, the Chief Financial Officer of the Commission has certified that the funds are available for these emergency services.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission, in accordance with the provisions of <u>N.J.S.A.</u> 58:5-20 and Section I, Subsection I of its Purchasing Policies and Procedures Manual, that the degradation of the sodium hypochlorite tanks constitutes an emergency warranting immediate action and replacement of the tanks with new HDPE Tanks without the necessity of engaging in public advertisement and bidding; and

BE IT FURTHER RESOLVED that the Board of Commissioners hereby ratifies the actions of the Executive Director and CFO of the Commission in determining that an emergency exists; and

BE IT FURTHER RESOLVED that the Board of Commissioners hereby authorizes the retention of Ryan to provide up to four (4) new HDPE Tanks as an emergency, without public bidding, for an amount not to exceed \$168,000.00, and the additional expenditure of not to exceed \$20,000.00 for rigging and crane charges relating to the installation of the tanks; and

BE IT FURTHER RESOLVED that a copy of this resolution shall be maintained in the Office of the Executive Director and made available for public inspection.

Commissioner Ashkinaze offered a motion to adopt the resolution authorizing the emergency replacement of sodium hypochlorite tanks; seconded by Vice Chairman Burrell and unanimously approved with Chairman Shotmeyer, Vice Chairman Burrell and Commissioners Ashkinaze, Amedeo and Kuser voting in the affirmative.

RESOLUTION OF THE NORTH JERSEY DISTRICT WATER SUPPLY COMMISSION APPROVING THE EXECUTION OF JOINT FUNDING AGREEMENT NO. 19LJJFA28 BETWEEN U.S. GEOLOGICAL SURVEY, UNITED STATES DEPARTMENT OF THE INTERIOR AND THE NORTH JERSEY DISTRICT WATER SUPPLY COMMISSION

WHEREAS, the North Jersey District Water Supply Commission ("Commission") is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its participating municipalities; and

WHEREAS, the Commission is the holder of certain permits ("Permits") issued by the New Jersey Department of Environmental Protection ("NJDEP") that allow it to pump water from both the Passaic River and Ramapo Rivers as needed; and

WHEREAS, as a condition of the Permits, the Commission is required to investigate and monitor the water resources in conjunction with the U.S. Geological Survey, United States Department of the Interior ("USGS"); and

WHEREAS, the Commission is in receipt of Joint Funding Agreement No. 19LJJFA28 (the "Agreement") with the USGS for the purpose of: (1) continuing the investigation and monitoring the water resources, specifically the operation and maintenance of two (2) continuous-record discharge gaging stations at Ringwood Creek near Wanaque and Wanaque River in Wanaque, which are key points in the Wanaque River basins; (2) continuing the investigation and monitoring of the Passaic River near Two Bridges and Ramapo River at Pompton Lakes, recording hourly water temperature, pH, specific conductance, and dissolved oxygen percent saturation, and (3) two (2) surface water low-flow sites, and a stage-only gage station; and

WHEREAS, the Agreement states that the Commission will contribute the sum of \$186,860.00 to the USGS, for the period from October 1, 2018 to September 30, 2019, to cover the cost of the necessary field and analytical work as set forth in the Agreement; and

WHEREAS, the Commission desires to approve the execution of the Agreement and authorize the payments in accordance therewith.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission that the Commission hereby approves the execution by the Executive Director of Joint Funding Agreement No. 19LJJFA28 between U.S. Geological Survey, United States Department of the Interior and the North Jersey District Water Supply Commission effective October 1, 2018 to September 30, 2019; and

BE IT FURTHER RESOLVED, that the Commission authorizes the payment to the USGS in accordance with the terms of the Agreement; and

WHEREAS, on or about April 11, 2017, the Commission publicly advertised and solicited proposals for the Services, which included the following six (6) tasks:

Task 1 - Washwater Tank Painting and Rehabilitation;

Task 2 - Surge Tank Painting and Rehabilitation;

Task 3 - Filters 1 through 10 Roof Steel Painting and Lighting (Filter Bays 1 through 13) and Misc. items;

Task 4 - Surface Wash and Washwater Pump Rooms Painting, and Drain Channel Piping;

Task 5 - Pipe Gallery Painting in area of Filters 1 through 10; and

Task 6 - Pipe Gallery Painting in area of Filters 11 through 13.

WHEREAS, on or about June 28, 2017, the Commission adopted a resolution awarding a contract to Alpine Painting & Sandblasting Contractors ("Alpine") for Tasks 3-6 in the not-to-exceed amount of \$3,093,684.00 ("Contract 2022"); and

WHEREAS, during the performance of the Services, Commission engineering staff discovered additional deficiencies in the facilities located in the Washwater Pump Rooms, the Pipe Gallery, the Surface Wash Room, and the Filter Building, and recommended that the necessary repairs be undertaken in connection with Contract #2022; and

WHEREAS, at the request of the Commission, Alpine submitted a proposed Contract

Amendment No. 1 to perform the additional repair work in the amount of \$232,800.00; and

WHEREAS, Commission staff examined Alpine's proposed Amendment No. 1 to Contract #2022 and determined that the services and fees set forth therein are reasonable, necessary and appropriate, and recommended that the Commission authorize said amendment; and

WHEREAS, on May 23, 2018, the Commission approved Amendment No. 1 to Contract #2022; and

WHEREAS, during the course of work pursuant to Amendment No. 1 to Contract #2022, it was determined that additional work is necessary in the area of the Filter Bays, including the caulking, painting of door hardware, replacement of all tread supporting electrical conduits, and painting of concrete walls (collectively "Painting of Filter Bays"); and

WHEREAS, Alpine has provided a proposal to undertake the additional work at a cost of \$385,947.00; and

WHEREAS, the Commission has determined that it is necessary and appropriate that Alpine undertake this necessary work in conjunction with its ongoing contract services, and that the costs are reasonable under the circumstances; and

WHEREAS, the Commission and Alpine desire to enter into Amendment No. 2 to Contract #2022 for the provision of the Painting of Filter Bays; and

WHEREAS, the Chief Financial Officer of the Commission has certified that the funds are available for this Amendment No. 2 to Contract #2022.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission that Amendment No. 2 to Contract #2022 with Alpine be and is hereby approved in the not-to-exceed amount of \$385,947.00; and

WHEREAS, the North Jersey District Water Supply Commission ("Commission") is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its

participating municipalities; and

WHEREAS, on August 30, 2018, the Commission's maintenance crew discovered a leak ("Jackson Avenue Leak") at the Jackson Avenue cross connection chamber in Wayne which was found to be spilling out onto the roadway; and

WHEREAS, in order to perform a repair of this leak, the Commission needs to isolate the west leg of the Wanaque North Aqueduct from the Jackson Avenue cross-connection to the Newark-Pompton Turnpike (NPT) cross-connection vault, in which are also located two (2) joint leaks which need to be addressed while this portion of the aqueduct is out of service (the "Joint Leaks"); and

WHEREAS, in light of the foregoing, the Commission's engineering staff recommended that the Commission immediately proceed to have the necessary repairs performed on an emergency basis; and

WHEREAS, pursuant to its enabling legislation, <u>N.J.S.A.</u>, 58:5-20, the Commission is entitled to undertake work by its own employees or outside contractors when the safety or protection of its or other public property or the public convenience requires, or the exigency of the situation will not allow for advertisement or public bidding to address any emergency conditions; and

WHEREAS, pursuant to Section I, Subsection I of its Purchasing Policies and Procedures Manual, the Commission may make purchases of materials and services without the necessity of public bidding when it is determined by the Commission's Executive Director and Chief Financial Officer ("CFO") that an emergency exists; and

WHEREAS, based upon the recommendation of the Commission's engineering staff, the Commission's Executive Director and CFO have determined that the Jackson Avenue Leak constitutes an emergency warranting immediate action and repairs without the necessity of engaging in public advertisement and bidding and that the Joint Leaks should be addressed on the same basis since they must be repaired while that portion of the aqueduct is out of service to repair the Jackson Avenue Leak; and

WHEREAS, the Commission has obtained a quote on a time and materials basis for the emergency repairs from J. Fletcher Creamer & Son, Inc. ("Creamer"), a qualified firm experienced in the work necessary to expeditiously undertake these emergency repairs with respect to the Jackson Avenue Leak and the Joint Leaks; and

WHEREAS, the Commission has determined that Creamer's rates are reasonable under the circumstances; and

WHEREAS, the preliminary estimated cost of the necessary repairs is \$52,000.00; and

WHEREAS, the Commission has authorized Creamer to perform the necessary emergency repair work to the Jackson Avenue Leak and the Joint Leaks on a time and materials basis; and

WHEREAS, the Chief Financial Officer of the Commission has certified that the funds will be available for these emergency services.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission, in accordance with the provisions of <u>N.J.S.A.</u> 58:5-20 and Section I, Subsection I of its Purchasing Policies and Procedures Manual, that the repairs of the Jackson Avenue Leak and the Joint Leaks constitute an emergency warranting immediate action and repairs without the necessity of engaging in public advertisement and bidding; and

BE IT FURTHER RESOLVED that the Board of Commissioners hereby ratifies the actions of the Executive Director and CFO of the Commission in determining that an emergency exists; and

BE IT FURTHER RESOLVED that the Board of Commissioners hereby authorizes the retention of Creamer to undertake the emergency repairs, without public bidding, on a time and materials basis; and

BE IT FURTHER RESOLVED that a copy of this resolution shall be maintained in the Office of the Executive Director and made available for public inspection.

WHEREAS, the North Jersey District Water Supply Commission ("Commission") is a public body corporate duly organized and existing under and by virtue of the laws of the State of New Jersey, exercising public and essential governmental functions and providing for the public health and welfare, and is engaged in developing raw water sources, storing water and distributing a reliable supply of potable water to its participating municipalities; and

WHEREAS, the Commission currently utilizes an array of actuators and metering pumps in its water treatment plant (the "Treatment Plant");

WHEREAS, the Commission is seeking to standardize its use of actuators and metering pumps across the Treatment Plant for maintenance and economic efficiency; and

WHEREAS, it is in the Commission's best interest to standardize the purchase and replacement of actuators and metering pumps in the Treatment Plant because it provides familiarity for operators and maintenance technicians in both routine and emergency situations, limits the amount of spare parts required in inventory, and improves Treatment Plant reliability; and

WHEREAS, Commission staff have evaluated and tested various brands of actuators and metering pumps, and recommended that the Commission utilize Rotork Controls, Inc. actuators (the "Actuators") and Blue-White Industries Pro-Series metering pumps (the "Pumps") as the standardized equipment for the Treatment Plant;

WHEREAS, the Commission has received confirmation that Technical Components Co. ("Technical") is the exclusive distributor of the Actuators and Pyrz Water Supply Co. ("Pyrz") is the exclusive distributor of the Pumps in New Jersey; and

WHEREAS, as a result of the foregoing, the Commission has determined that Technical and Pyrz constitute sole source providers of the Actuators and Pumps, respectively; and

WHEREAS, the Commission desires to authorize the purchase of the Actuators and Pumps from Technical and Pyrz, respectively, in an amount as may be deemed necessary by Commission staff in consideration of ongoing Treatment Plant requirements; and

WHEREAS, this sole source award is necessary for the Commission's efficient water treatment and delivery operations, the protection of the Commission's water supply facilities, and the health, safety and welfare of the public; and

WHEREAS, the Chief Financial Officer of the Commission will certify that the funds are available prior to any necessary purchases of the Actuators and Pumps.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission that Technical and Pyrz be and are hereby designated the sole supplier of the Actuators and Pumps, respectively; and

BE IT FURTHER RESOLVED that Commission staff is authorized to purchase the Actuators and Pumps as may be required in light of ongoing Treatment Plant needs, provided that adequate funds are available for said purchases; and

BE IT FURTHER RESOLVED that the Chairman or Vice Chairman of the Commission is hereby authorized to execute any necessary contracts to facilitate said purchases and the Secretary of the Commission is authorized to attest to the signature of either the Chairman or the Vice Chairman; and

BE IT FURTHER RESOLVED that a copy of this resolution shall be maintained in the Office of the Executive Director and made available for public inspection.

Commissioner Ashkinaze offered a motion to adopt the resolution authorizing sole source contract awards for the purchase of metering pumps and actuators; seconded by Vice Chairman Burrell and unanimously approved with Chairman Shotmeyer, Vice Chairman Burrell and Commissioners Ashkinaze, Amedeo and Kuser voting in the affirmative.

WHEREAS, the sale and disposition of such surplus vehicles and equipment is necessary for the Commission's efficient operations and the protection of its water supply facilities; and

WHEREAS, the Commission had previously authorized the sale of surplus vehicles and equipment through GovDeals, a state contract online government surplus auction website; and

WHEREAS, the Commission desires to sell the surplus vehicles and equipment identified on Exhibit A through GovDeals.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the North Jersey District Water Supply Commission that the Commission hereby approves and authorizes the sale and disposition of surplus vehicles and equipment identified on Exhibit A attached hereto through GovDeals as follows:

(1) The sale of the surplus property shall be conducted through GovDeals pursuant to State Contract A-83453/T2581 in accordance with its terms and conditions.

(2) The sale will be conducted online and the address of the auction site is

govdeals.com.

(3) The sale is being conducted pursuant to Local Finance Notice 2008-9;
